effective March 1, 2026

Members may notice changes to transaction fees when package plan limits are exceeded.

Wire transfer fees will be based on the total amount sent. Wires under \$10,000 will be offered at a reduced cost, with an increase for wires over \$10,000.

### Personal package plans:

All package plans include FREE unlimited e-Transfers\*, Deposit Anywhere™ cheque deposits, and a fee waiver with a minimum balance\*\*.

Enjoy the added benefit of linking your package to a second account at no extra cost.

### Commercial package plans:

A wider selection of plans is available to support all your business needs.

All plans include cash deposits, incoming e-Transfers, and Deposit Anywhere™ cheque deposits at no additional cost, except for the Business Pay-As-You-Go plan.
