effective May 1st, 2023



Changes to service charges are necessary to ensure East Coast Credit Union remains competitive in the market and can continue to enhance products and services to meet our members' needs. Although we expect minimal impact on the majority of our members, please note some daily transaction fees will increase. Refer to the table below for more information.
